Teletalk payment

**SMS & PIN:** Go to your SMS option and type **BTCL <space> INVOICE ID Send to 16222**. You will get a PIN\_NUMBER in return message  
**PAYMENT:** To confirm payment, in SMS type **BTCL<space>YES<space>PIN\_NUMBER**
